1 RULES

1.1 The event will be governed by the rules as defined in The Racing Rules of Sailing – Windsurfing Edition (WCR).

1.2 The Classes Rules will apply (unless otherwise modified by this Notice of Race and the Sailing Instructions).

1.3 The National Authority prescriptions 2 and 3 shall apply for the Greek competitors.

1.4 If there is a conflict between languages the English text will take precedence.

1.5 If there is a conflict between the Notice of Race and the Sailing Instructions the Sailing Instructions shall take precedence.

2 ADVERTISING

Boards may be required to display advertising chosen and supplied by the organizing authority. World Sailing Regulation 20 'Advertising Code' shall apply.

3 DIVISIONS

3.1 The participating divisions shall be:

3.1.1 Techno 293 - Junior Boys & Girls.

3.1.2 Techno 293 - Youth Boys & Girls.

3.2.1 Techno 293 Plus - Open Men & Women

3.3.1 RS:X - Youth Boys & Girls.

3.3.2 RS:X - Men & Women

3.4.1 Raceboard - Men & Women

3.5.1 Division II - Men & Women

3.6.1 Kids: may race with any board less than 320m, with dagger board, with any rig make, only for kids under 15 years old.

3.6.2 Kids Open 3.5 - for boys & girls with sail less than 3.5sqm

3.6.3 Kids Open 4.5 - for boys & girls with sail less than 4.5sqm

3.6.4 Kids Open 5.8 - for boys & girls with sail less than 5.8sqm

3.7 A minimum of 5 competitors is required to constitute a division.

4 ELIGIBILITY AND ENTRY

4.1 Entries shall meet the requirements of World Sailing Regulation 19-Eligibility Code. In the Division II class all participants shall be members of ID2CA and the equipment must be tagged by the ID2CA stickers.

4.2 Eligible competitors may enter online - bank transfer payment required. **On-line entry will close on 25th September 2020**.

4.3 The following shall be presented upon registration:

• Evidence of valid third party insurance

• Proof of age (passport)

Parental Permission Form

4.4 Greek competitors shall be in compliance with the HSF rules (valid EIO card). This card must be submitted to the Registration Office at registration.

4.5 Support personnel may **register online** - bank transfer payment required.

The following shall be presented upon registration:

Boat Driving License

• Evidence of valid third party insurance

5 ENTRY FEES

5.1 The required fees are: 80 euro.

5.2 Competitor entry fees paid by 3rd September shall receive a 30 euro discount.

5.3 A fee of 30 euro is required for support personnel.

5.4 Entry fees paid at registration shall be paid in cash - Euros.

6 RACE FORMAT

6.1 The event shall be a racing, "open entry" event.

6.2 Boys and girls or men and women may race together depending upon entry numbers.

6.3 Competitors shall race a maximum 4 races per day, in a maximum of 8 races.

6.4 There will be one discard if 4 or more races are completed.

6.5 One race is required to validate the race for each division.

7.2 Competitors and Team Leaders shall complete on-site registration forms at the Registration Office on **Friday 2nd October 09:00 - 18:00**

8 EQUIPMENT & EQUIPMENT INSPECTION

8.1 Equipment inspections may be made at any time during the event.

8.2 Upon completion of registration and until the end of the event, at all times when ashore except when launching and retrieving from the designated area, all equipment shall be kept in their assigned places at event site. Removal of any equipment from the event site requires prior written approval from the race committee. Access to equipment in the storage area during certain hours, including hours of darkness may be restricted.

9 SAILING INSTRUCTIONS

The sailing instructions (SI's) will be available no later than event registration.

10 COURSES

Courses will be as described in the sailing instructions.

11 INTERNATIONAL JURY

An International Jury may be appointed in accordance with WCR Appendix N. There shall be no appeal from their decisions in accordance with WCR 70.5.

12 SCORING

Scoring will be according to the WCR Appendix A.

13 SUPPORT BOATS

Support boats shall be registered at the race office. Support boat drivers shall have a valid boat license and 3rd party liability insurance with a minimum cover of €1,500,000 per event or the equivalent.

14 SAFETY

14.1 Personal buoyancy is mandatory for every competitor and support boat crew member.

14.2 Every competitor and support boat crew member shall wear a personal flotation device that shall conform to the minimum standard of ISO 12402-5 (level 50).

14.3 Coach and support boat drivers shall use the kill cord in the recommended manner.

15 PRIZES

Prizes will be awarded to the first three competitors of each constituted division.

16 OFFICIAL CEREMONIES

Competitors are requested to attend the event's social functions; however, the organising authority may refuse entry to those whose standard of attire is not commensurate with the occasion. **Prize winners may forfeit prizes for non-attendance at the prize giving ceremony.**

17 DISCLAIMER OF LIABILITY

Competitors participate in the event entirely at their own risk, see WCR 4 -Decision to Race. The organising authority or any of their officials or representatives or the sponsors or their officials or representatives will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during or after the event.

18 INSURANCE

Each participating board shall be insured with valid third party liability insurance with a minimum cover of 540,000 euros per event or the equivalent.

19 RIGHT TO USE NAME AND LIKENESS

In registering for the event, competitors automatically grant to the Organising Authority the right in perpetuity to make, use and show from time to time at their discretion, any motion pictures, still pictures and live, taped or filmed television and other reproduction of them, taken during the period of the event, for the said Event as defined in the Notice of Race and Sailing Instructions in which he/she participates without compensation.
