#### 1. RULES

- 1.1. The event will be governed by the rules as defined in the <u>Windsurfing Slalom</u>
  Racing Rules (WSRR) and the IFCA Championship Rules.
- **1.2.** No national prescriptions will apply.
- **1.3.** If there is a conflict between languages, the English text will take precedence.
- **1.4.** In all rules governing this regatta:
  - **a.** [SP] denotes a rule for which a standard penalty may be applied by the race committee or technical committee without a hearing, or a discretionary penalty applied by the International Jury with a hearing. This changes WSRR 63 and A5.
  - **b.** [NP] denotes a rule that shall not be grounds for protests by a board. This changes RRS 60.1.
- **1.5.** Supplemental Sailing Instructions (*SSI*) will be published at least one hour before the first possible warning signal. The SSI may change or supplement rules in these NoR/SI
- 1.6. In case of a discrepancy within the Notice of Race or Sailing Instructions and the Supplemental Sailing instructions, the Supplemental Sailing Instructions will take precedence.

#### 2. DIVISIONS

**2.1.** The championships are open for the IFCA Fin and the Foil division

#### 2.2. Age Divisions

- **a.** A Youth shall be under the age of 21 (born in or after 2005).
- b. A Junior shall be under the age of 17 (born in or after 2009).
- **c.** A Junior Under 15 (born in or after 2011).
- d. A Junior Under 13 (born in or after 2013).
- e. A Master shall be over the age of 40 (born in or before 1984).
- **f.** A Grand Master shall be over the age of 50 (born in or before 1974).
- g. A Legend shall be over the age of 60 (born in or after 1964).

#### **2.3.** Title Divisions [official titles]

- **a.** Fin Youth (Men and Women)
- **b.** Fin Junior (Boy and Girl)
- c. Fin Open (Men and Women)
- d. Fin Master
- e. Foil Open
- **f.** Foil Youth (Men and Women)
- **2.4.** A minimum of 3 competitors is required to constitute a prize division.

#### 3. ELIGIBILITY AND ENTRY

- **3.1.** All entries shall meet the requirements of World Sailing Regulation 19-Eligibility Code.
- **3.2.** Competitors shall be members of a National Class Association which is a paid up member of the international class association, or of the IWA.
- **3.3.** Eligible competitors may <u>enter online</u> credit/debit card or bank transfer payment required. **Online entry will close on 05.08.2025**
- **3.4.** An entry is not **valid** until the entry fee is paid.
- **3.5.** The maximum number of entries for each division is 80.
- 3.6. Entries will be accepted in the order that a **valid** entry (with payment) is received. When the maximum number of **valid** entries is received, further entries will not be accepted.
- **3.7.** The following shall be presented upon registration:
  - Evidence of valid third party insurance
  - Proof of age
  - Parental Permission Form for those under the age of 18
  - For Italian competitors only: All Italian competitors shall have a valid card
    of the Italian Sailing Federation which includes a valid medical certificate and
    the AICW membership card

#### 4. FEES

- **4.1.** The entry fee is: 200 euro; except Youth-170 euro.
- **4.2.** A discount of 30 euro applies for entries received before **05.07.2025**
- **4.3.** Late entries accepted at registration will be surcharged 20 euro.
- **4.4.** Entry fees paid at registration shall be paid in cash (euro).
- **4.5.** Entry fees paid by bank transfer to:

#### 5. RACE FORMAT

- **5.1.** The Championships shall be:
  - a. FOIL, slalom racing, "open entry" event in wind conditions less than 15 knots (this changes Championship Rule 9).
  - b. FIN, slalom racing, "open entry" event in wind conditions more than 11 knots.
  - c. FOIL OR FIN, slalom racing, "open entry" event at the discretion of the principal race officer in wind conditions from 11 knots to 15 knots.

This changes Championship Rule 9

- **5.2.** Men and women may race together.
- **5.3.** Junior and Youth may race together
- 5.4. There will be a maximum of 4 eliminations per day except for the divisions that sail in single fleets for who 8 races per day is the maximum.

**5.5.** One completed elimination, including both A and B finals, is required to validate the event in each division.

#### 6. SCHEDULE

- 6.2 There will be a daily **skipper meeting** 1 hour before the first possible warning signal of that day.
- The starting schedule will be posted on the Official Notice board at least 15 minutes before the first warning signal of the elimination involved.
- **6.4** The schedule is subject to alteration.
- 6.5 At the discretion of the Race Committee, races may be rescheduled.
- 6.6 To alert boats that an elimination or sequence of eliminations will begin soon, the orange starting line flag will be displayed with one sound at least five minutes before a warning signal is made on the Race Committee Signal Boat on the windward end of the starting line.
- 6.7 The numbering of the eliminations will be in order of sailing, except if an elimination is abandoned after it has been sailed.

#### 7 EQUIPMENT & EQUIPMENT INSPECTION

- 7.1 An Online Equipment Registration Form shall be completed by each competitor and submitted before the end of registration on 12.08.2025 17:00
- 7.2 Substitution of damaged or lost equipment will not be allowed unless authorized by the Race Committee. Requests for substitution shall be made in writing at the first reasonable opportunity. Forms for replacement are available at the Race Office.
- 7.3 A board or equipment may be inspected at any time for compliance with the Class Rules and Sailing Instructions. On the water, a board can be instructed by the Race Committee to proceed immediately to a designated area for inspection.
- 7.4 [SP] National letters and numbers: Penalties for breaches of WSRR appendix G may be less than disqualification. Penalty for a breach of this SI will be 1 point for every race.

#### 8 NOTICE TO THE COMPETITORS

**8.1** Notices to competitors will be posted on the Official Notice Board (ONB) in front of the Raceoffice.

#### 9 CHANGES TO SAILING INSTRUCTIONS

- **9.1** Any change to the SI or SSI will be posted at least 15 minutes before the starting time of the race or races concerned.
- **9.2** Changes affecting the schedule of the next day's racing shall be posted:
  - a. within the protest time limit or
  - **b.** before AP ••• over A is displayed whichever is later.
- 9.3 If oral instructions or changes to the sailing instructions will be given on the water, the flag ICF "L" shall be shown at least 5 minutes before the instructions or changes. Sufficient effort has to be made to inform all the competitors involved.

#### 10 SIGNALS MADE ASHORE

- **10.1** Signals made ashore will be displayed on the Official Flag Poles located on the beach near the launching area.
- **10.2** When flag AP ▶ is displayed ashore, 1 minute is replaced with "not less than 15 minutes". This changes WSRR Race Signals.
- **10.3** [NP] [SP] When flag D is displayed ashore with one sound signal, competitors shall not leave the shore.
- **10.4** When flag **FOIL** is displayed the next start will be in the foil division



**10.5** When flag **FIN** is displayed the next start will be in the fin division



- 10.6 If a signal flag is displayed simultaneously with a class flag, this signal flag only applies to the class in question. If no class flag is shown, the signal flag applies to all classes
- 10.7 The ladder will be published and be posted at least 15 minutes before the starting time of the race or races concerned on the internet. On the Official Noticeboard a QR code will be published for this website.

#### 11 CLASS FLAGS

11.1 The class flags will be prescribed in the SSI

#### 12 RACING AREA AND COURSES [SP] [NP]

- **12.1** The racing area will be as illustrated in Appendix A and defined as follows:
  - At least 75 meters from any board racing (except a board in distress requiring assistance) or to a mark, finish line or lay line.
  - From the attention signal until the starting signal at least 300 metres from the pre-side of the starting line.
- **12.2** Courses will be as prescribed in the IFCA Slalom Championship Rules or variations of it. The course diagram (not to scale) will be posted on the ONB at least 15 minutes before the start of the heats to which it applies.
- **12.3** [SP] Boards whose warning signal has not been given and support vessels shall avoid the racing area.
- 12.4 [SP] The restricted areas, if any, will be prescribed in the SSI

#### 13 MARKS

**13.1** The marks will be prescribed in the SSI

#### 14 START

- **14.1** The starting line will be between the flagpole with the orange flag on the Race Committee Signal Boat and the starting mark.
- **14.2** Start on water; according to WSRR 26.1
- **14.3** Start from beach; according to WSRR 26.2
- 14.4 The starting signals will be shown from the Race Committee Signal Boat on the windward end of the starting line, seen in the direction of the first mark or from a flagpole to windward of the starting line in case of a beach start.
- **14.5** Repetitive sound signals will be given when flag "1st substitute" ➤(general recall) is displayed. This changes WSRR Race Signals

#### 15 RECALLS [NP]

**15.1** Recalls will be signalled in accordance with WSRR 29.1

## 16 FINISH [SP] [NP]

**16.1** The finishing line will be between the finishing mark and a pole with a checkered flag.



- **16.2** [SP] All boards that have finished shall keep clear of competitors still racing and shall leave and clear the racing area as soon as reasonably possible.
- **16.3** When flag H ☐ is displayed on the finish line boards shall go ashore for more information after finishing.

#### 17 TIME LIMITS

- 17.1 Boards failing to start within 1 minute after her starting signal will be scored Did Not Start without a hearing. This changes WSRR 63.1, A4 and A5.
- **17.2** Boards failing to finish within 3 minutes after the first board in their heat has sailed the course and finished will be scored Did Not Finish (DNF) without a hearing. This changes WSRR 63.1, A4 and A5.

#### 18 JURY AND PROTESTS

- **18.1** An International Jury shall be appointed in accordance with ESCR Appendix N. There shall be no appeal against their decisions.
- **18.2** Protests and requests for redress shall be made orally to a member of the jury as soon as reasonably possible after the competitor finished the race.
- **18.3** The protestor shall make every reasonable effort to bring the protestee and the witnesses if any, to the jury.
- **18.4** The location of the jury will be as prescribed in the SSI and will be signaled by a white flag with "JURY".



**18.5** Special attention will be for WSRR 61.1: "The protesting board shall inform the other board at the first reasonable opportunity. She shall also inform the race committee on the finishing line of her intention to protest as soon as practicable after she finishes or retires and shall inform the protestee."

#### 19 SCORING

- **19.1** WSRR Appendix A applies.
- **19.2** WSRR A.4.1 is changed in:
  - A.4.1 Each board, except board given redress, shall be scored points as follows:

| Finishing place       | Points      |
|-----------------------|-------------|
| First                 | 0,7         |
| Second                | 2           |
| Third                 | 3           |
| Fourth                | 4           |
| Fifth                 | 5           |
| Each place thereafter | Add 1 point |

#### 20 SAFETY REGULATIONS [SP] [NP]

20.1 The safety of the sailboard and its entire management including insurance shall be the sole responsibility of the competitor racing the sailboard who must ensure that the sailboard is adequate to face the conditions that may arise in the course of the

race. Neither the establishment of these sailing instructions nor the inspection of the board under these conditions in any way limits or reduces the absolute responsibility of the competitor for his/her board and entire management thereof. The Race Organizers, the Race Committee and the International Jury will not be responsible for any loss, damage, death or personal injury however caused to the competitors as a result of their taking part in the race or races.

- 20.2 [SP] Flotation devices: When flag "Y" is displayed, every competitor shall wear a personal flotation device that shall conform to the minimum standard ISO 12402-5 (Level 50).
- 20.3 [SP] If either one of the signals "N ❖ over H" ☐, "N ❖ over A" ☑, "AP ☑ over H" ☐ or "AP ☑ over A" ☑ is made on one or more RC vessels, boards shall return to the competitors' area on the beach as soon as reasonably possible.
- **20.4** [SP] Competitors shall go afloat and ashore in the competitors' area only on the beach in front of the Race office.
- **20.5** [SP] For men and women helmets are mandatory in the Foil division (see Class rule C.3.2)
- **20.6** [SP] For youth and junior helmets are mandatory in the Foil and Fin division (see Class rule C.3.2)
- **20.7** All participants are advised to wear an impact vest.

#### 21 EVENT ADVERTISING [SP] [NP]

- 21.1 Sailors may be required to display advertising chosen and supplied by the organising authority. World Sailing Regulation 20 'Advertising Code' shall apply.
- 21.2 [SP] Competitors are required to wear the advertising lycra, as provided by the organizer at the registration, while racing, training and on the race site. In case of loss or damage of the original lycra vest a new lycra vest can be collected at the race office. A refundable deposit of 20 euros shall be paid and returned if the spare Lycra vest is returned undamaged at the end of the event.
- **21.3** [SP] The lycra vest shall be worn outside other clothing when going afloat for training or racing.
- **21.4** [SP] Organizers sail stickers are mandatory on all sails while racing. The sticker shall not be cut or adopted in any way.
- **21.5** [SP] The IFCA class stickers are mandatory on all sails at all times during the event.

# 22 SHORE REGULATIONS [DP] [NP] [SP]

**22.1** [DP] The instructions of the RC or the Beach master shall be strictly obeyed.

## 23 TRASH DISPOSAL [DP] [NP]

**23.1** While afloat, trash may be placed aboard support - and race committee boats.

#### 24 COACHES & SUPPORT BOATS

**24.1** Coaches and support boats shall be registered at the Race Office.

- **24.2** Support boat drivers shall have a valid boat license and third party liability insurance.
- **24.3** Team leaders, coaches and other support persons shall stay outside the racing area
- **24.4** Support boats shall be marked as follows:
  - the three-letter NOC code shall be clearly displayed on both sides of the boat in strongly contrasting colors at all times while afloat;
  - the minimum height for the letters shall be 200 mm. The letters will not be provided by the Organizing Authority.

#### 25 PRIZES

- **25.1** Prizes shall be awarded to the top 3 competitors in each properly constituted division
- **25.2** The first Men in the FIN division will be declared "IFCA Fin Slalom Men World Champion".
- **25.3** The first Women in the FIN division will be declared "IFCA Fin Slalom Women World Champion".
- **25.4** The first Master in the FIN division will be declared "IFCA Fin Slalom Master World Champion".
- **25.5** The first Youth Men in the FIN division will be declared "IFCA Fin Slalom Youth Men World Champion".
- **25.6** The first Youth Women in the FIN division will be declared "IFCA Fin Slalom Youth Women World Champion".
- **25.7** The first Junior Boy the FIN division will be declared "IFCA Fin Slalom Junior Boy World Champion".
- **25.8** The first Junior Girl in the FIN division will be declared "IFCA Fin Slalom Junior Girl World Champion".
- **25.9** The first Competitor in the Foil overall division will be declared "IFCA Foil Slalom Open World Champion".
- **25.10** The first Youth Men in the FOIL division will be declared "IFCA Foil Slalom Youth Men World Champion".
- **25.11** The first Youth Women in the FOIL division will be declared "IFCA Foil Slalom Youth Women World Champion".
- **25.12** There will be a 20.000 euro prize fund, to be distributed as per Appendix A of the IFCA Championship rules for the Men, Women and Open Foil Divisions
- **25.13** There may be additional prizes for the valid non title divisions

#### 26 OFFICIAL CEREMONIES

Competitors are requested to attend the event's social functions; however, the organising authority may refuse entry to those whose standard of attire is not commensurate with the occasion. Prize winners may forfeit prizes for non-attendance at the prize giving ceremony.

#### 27 DISCLAIMER OF LIABILITY

Competitors participate in the event entirely at their own risk, see ESCR 4 - Decision to Race. The organising authority or any of their officials or representatives or the sponsors or their officials or representatives will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during or after the event.

#### 28 INSURANCE

Each participating competitor/support boat driver shall be insured with valid third party liability insurance with a minimum cover of 1,500,000 euro per event or the equivalent.

#### 29 RIGHT TO USE NAME AND LIKENESS

In registering for the event, competitors automatically grant to the Organising Authority the right in perpetuity to make, use and show from time to time at their discretion, any motion pictures, still pictures and live, taped or filmed television and other reproduction of them, taken during the period of the event, for the said Event as defined in the Notice of Race and Sailing Instructions in which he/she participates without compensation.




## **COURSE AREAS**
